## Statewide Poll Finds Business Leaders High on Oklahoma, but concerned about Workforce, Taxes, and Education

Business leaders view Oklahoma as a good place to do business, with an overwhelming majority of those surveyed saying they will make investments in Oklahoma in the coming year.

Despite generally believing Oklahoma's economy is headed in the right direction, Oklahoma business leaders identify challenges related to workforce, education, and taxes the state needs to tackle to remain competitive regionally and nationally.

Those are among the opinions business leaders expressed in the 2022 Business Leaders Poll, an annual collaborative project of The State Chamber, the Oklahoma Business Roundtable, and the State Chamber Research Foundation (SCRF) that has recently been released. This year's survey polled more than 350 business executives and leaders.

The annual poll is the only statewide, scientific survey that annually measures the sentiments, concerns, and outlook of business leaders—from the C-suites to the corner stores—who shape Oklahoma's economy.





**2022 Business Leaders Poll** 

Oklahoma business leaders were positive about the current and future business environment in Oklahoma.

- 79% of leaders say their company will make investments in Oklahoma over the next year.
- 63% say compared to the national economy, Oklahoma's is going in the right direction.
- 62% identified workforce challenges as their top concern.

"Oklahoma businesses are the engine of our state's growth and success," said Chad Warmington, President and CEO of The State Chamber. "The goal of the Business Leaders Poll is to ensure state leaders understand the perspectives of the people on the front lines of Oklahoma's economy, the men and women who run businesses, large and small."

According to the poll, business leaders are unified in the belief that Oklahoma needs better results from its education system.

- 87% think Oklahoma's higher education system needs to do a better job of incentivizing students to study in fields where there is a greater workforce need.
- 62% believe that school choice options like charter schools and funding for private school options will increase the overall effectiveness of the K-12 education system.

"It's clear from the survey data that business leaders see improving Oklahoma's education system as the top priority for improving the workforce talent pipeline," said Ben Lepak, Executive Director of the State Chamber Research Foundation. "This matches what we see in educational outcomes statistics, where Oklahoma is routinely near the bottom of the national rankings. Today's students are tomorrow's workforce, and businesses have to plan for the long-term."

"I think overall, business leaders are positive about Oklahoma's economic climate and the state's businessfriendly attitude, but it's also clear that they have some strong concerns about particular issues," said Mark Funke, President and CEO of the Oklahoma Business Roundtable.

Business leaders also identified Oklahoma's individual income tax as in need of reform. While a majority think the overall tax burden on their business is not too high, leaders say reform of the individual income tax needs to be prioritized to stay economically competitive.

## Tulsa's L3 Harris Facility to Produce New Military Aircraft

U.S. Special Operations Command has selected L3Harris Technologies and Air Tractor, Inc.'s AT-802U Sky Warden<sup>™</sup> system for its Armed Overwatch program. The program includes delivery of up to 75 manned, fixed wing aircraft, with an initial program contract award of \$170 million. Production of the new, fully-modified, Armed Overwatch mission-configured aircraft will begin in 2023 at L3Harris' Tulsa, Okla. modification center, following initial production at Air Tractor's Olney, Texas aircraft manufacturing facility.

### **Oklahoma Delegation Promotes Aerospace Industry at Global Trade Show**





Oklahoma's largest-ever delegation of company and community partners at the Farnborough Airshow in July.

Governor Kevin Stitt led a special Oklahoma business and economic development mission to the UK in July for the biennial Farnborough International Airshow, the world's largest civil and military airshow. The primary goal was to support the growth of Oklahoma-based companies and connect potential investors with state location and expansion opportunities. With support from the Commerce Department, the Roundtable and partners, the group held over 75 meetings with prospects and executives including Boeing, GE Aviation, Raytheon, Airbus, Embraer, Spirit Air Systems and Kratos. Ten Oklahoma companies, three universities and three communities worked out of the Commerce Trade Pavilion. A survey of the participating Oklahoma companies reported upward of \$47 million in direct and planned sales and 152 jobs retained or created as a result of attending the show.

The following week the Oklahoma business development team attended the EAA AirVenture trade show in Oshkosh, Wisconsin. This event was a great opportunity for the state to showcase its impressive training programs. <u>Oklahoma is ranked #1 in the U.S. for high schools teaching aviation curriculum</u>. During the upcoming school year, 57 schools in Oklahoma will be teaching the Aircraft Owners and Pilots Association (AOPA) High School Aviation STEM curriculum.

## Impact Partnership Grants To Benefit Workforce Growth

The Governor's Council for Workforce and Economic Development (GCWED) and the Oklahoma Office of Workforce Development (OOWD) have awarded five Impact Partnership Grants for investment in workforce growth.

Impact Partnerships promote and fill high-demand occupations in Oklahoma and strive to build lasting, collaborative relationships between business, eduaction, workforce development, according development and according to a strip OKLAHOMA WORKS

cation, workforce development, economic development and government and community organizations.

The Oklahoma Office of Workforce Development awarded five new applicants up to \$175,000 to invest in their industry-led, collaborative community projects. A total of \$1,000,000 in funding will be allocated to the awardees, extension projects, and Regional Workforce Boards.

The 2022 Impact Partnership Grant recipients are:

- <u>Oklahoma Rural Water Association (ORWA)</u>: Working with education and community partners to create a sustainable workforce for the essential water sector for Oklahoma.
- <u>The STEAM Engine</u>: A collaborative of companies in the areas of Architecture, Engineering and Construction (AEC) working to build a more cohesive and thriving AEC workforce. ADG, Blatt Architects, CMS Willowbrook, Guernsey and J.E. Dunn are participating.
- <u>Enid Regional Development Alliance</u>: Aerospace is the second largest and fastest growing industry sector in Oklahoma. The Enid Regional Development Alliance will use the Impact Partnership Grant to promote careers in aerospace including maintenance and repair and pilots as well as developing a pipeline for existing aviation support careers.
- <u>Broken Arrow Economic Development Corporation (BAEDC)</u>: As a STEM Workforce Center of Excellence, the BAEDC plans use the Impact Partnership Grant to create a navigable ecosystem for STEM education, training and career pathways. Their mission is to connect talent with education partners and businesses engaged in engineering.
- <u>Southern Workforce Board</u>: Development of a healthcare sector partnership to build a stronger talent pipeline. The southern Oklahoma consortium includes the Southern Workforce Board, Murray State College and the Executive Committee of JBAMM (Johnston, Bryan, Atoka, Marshall and Murray County regions) with additional resources from local chambers, education partners and community partners.

#### Office Visit: Transformative changes coming to Oklahoma Timothy Pehrson, President and CEO, Integris Health

For too long, Oklahoma has lagged behind the rest of our nation in health outcomes. A significant reason for this comes from the way we pay for health care. This year, the Oklahoma Legislature and governor made transformational reform to our payment structure, which should improve health outcomes of Oklahomans over time. Senate Bills 1337 and 1396 will change the way our health care system is paid by moving Medicaid, the government health care program for the underserved, toward value-based care. Value-based care means physicians and hospitals will be paid to keep patients healthy, rather than being paid a fee for service (FFS) or being paid per visit/procedure. FFS incentivizes all the wrong behaviors, resulting in overutilization of services, and often creating poorly coordinated care.



Starting in October of 2023, physicians, hospitals and health plans will be rewarded for collaborating to keep Oklahomans healthy rather than being siloed as they have been for too long. Taking care of patients in this coordinated way is a new skill that will require time, energy and money to develop the capabilities to do this well. Thankfully, the Legislature created incentives to encourage investment in developing these value-based care capabilities. The good news is that as the health care industry develops new competencies to better coordinate care in the Medicaid population, they can be applied to all Oklahomans as well. This should not only result in better health outcomes for our state, but also create more sustainable costs overtime.

The skills to practice medicine in this new value-based world won't be learned at once. We should not expect Oklahoma to move from 48th in the country for overall health to top 10 in a few years. However, the bold and forward-thinking move by the Legislature and governor have put Oklahoma on the right track to make improvements. Without this kick-start, Oklahoma would have been forever stuck at the bottom.

In the middle of political campaigns and the finger-pointing that accompanies them, it can be hard to notice the times when our elected leaders come together across parties and geography and solve problems together. Congratulations to Gov. Kevin Stitt, Rep. Marcus McEntire, Sen. Greg McCortney, and the bipartisan majorities in both chambers of the Legislature for accomplishing such a transformational reform during this year's legislative session. Generations of Oklahomans will be healthier because of their bold and creative move.

After 70 years of flying global missions with distinction, the Boeing B-52 bomber will receive a design and operational facelift. In April, the 70<sup>th</sup> anniversary of the first flight of the B-52 bomber, Boeing dedicated a new 60,000-plus square-foot addition to Boeing's Oklahoma City facilities, which has been specifically designed and built to modernize the historic long-range bombers.

*Graphic Design USA* has named The **University of Central Oklahoma's School of Design** as one of the top 50 design schools in the country.

- Oklahoma's June 2022 workforce of 1,817,175 people represents the largest number of workers in state history.
- Oklahoma City is now ranked as the 20th biggest city (by population) in America. according to latest U.S. Census estimates. Oklahoma City has an estimated population of 687,000 people. Tulsa is ranked 47th with a population of 411,000. Both Oklahoma metro areas (MSA's) register over 1 million in population.
- Jennifer McGrail is the new Executive Director of the Oklahoma Center for the Advancement of Science and Technology (OCAST). McGrail takes over for C. Michael Carolina who retired at the end of June. McGrail comes to OCAST following more than four years as the Director of the AXIS business incubator at Francis Tuttle Technology Center.



- *WalletHub* ranked Oklahoma City 16th) and Tulsa (17th) among the 100 best metros to visit on vacation this summer.
- Significant bridge reconstruction projects statewide have helped move Oklahoma up to No. 5 in the nation for having the lowest percentages of structurally deficient bridges on the highway system.
- 36 Degrees North, Tulsa's largest hub for entrepreneurs, has generated a combined economic impact of \$572.5 million over the last five years, the organization said in July. For the year, 36 Degrees North served 387 member companies that created or retained 2,181 jobs and generated sales of \$111.3 million. Additionally, companies at 36 Degrees North secured more than \$25 million in external funding, with the majority (84%) coming from venture capital investment.
- The Tax Foundation's 2022 *State Business Tax Climate Index* ranks Oklahoma 26th in the country. The state by state Index enables business leaders, government policymakers, and taxpayers to gauge how well states structure their tax systems and provides a road map for improvement. Oklahoma's recent legislative tax initiatives will be included in the next set of rankings.
- Working age people across the U.S. are searching for a better quality of life in the wake of the Covid-19 pandemic, according to a national survey conducted by Development Counsellors International (DCI). The *Talent Wars report*, was conducted among 1,000 people who relocated at least 100 miles from their previous residence.

### Oil & Gas Revenue Skyrockets in July
